

***For offline admission*** to the National University of Pharmacy, a foreign citizen personally submits a paper application to the admissions committee. The candidate adds to the application:

- 1) a copy of a foreigner's passport or a document certifying a stateless person;
- 2) a document (the original and its notarized copy) about the previously obtained educational degree (educational and qualification level), based on which admission is carried out;
- 3) an appendix (the original and its notarized copy) to the document on the previously obtained educational degree (educational and qualification level), based on which admission is carried out;
- 4) an academic certificate (original) issued by a foreign/Ukrainian educational institution (in case of transfer or renewal of studies, starting from the second year);
- 5) the original and a copy of the document with information on the content of the curriculum for the previous educational degree, received credits, duration of study and results in academic disciplines when entering to obtain a bachelor's and master's degree;
- 6) a medical insurance policy, unless otherwise is provided by international agreements of Ukraine;
- 7) a standardized questionnaire;
- 8) a certificate of completion of the pre-university training program (preparatory faculty, unit) is provided for admission to studies in the Ukrainian language;
- 9) 10 photos measuring 30x40 mm;
- 10) a copy of the certificate of a Ukrainian abroad (for persons who have the status of a Ukrainian abroad).

The documents specified in paragraphs 1-5 must be translated into Ukrainian with a notarized translation. The documents specified in paragraphs 2-5 must be certified in accordance with the legislation of the country of their issuance and legalized by the relevant institution of Ukraine abroad.

***For online admission*** to the National University of Pharmacy, a foreign citizen submits an application to the admissions committee in electronic and paper forms.

The candidate attaches the following documents in electronic and paper forms to the application:

1) a copy of a foreigner's passport or a document certifying a stateless person with an indication of the received visa for entering Ukraine for the purpose of study or a copy of a passport with legalized documents about education in the country of their issuance;

2) a document (notarized copy) about the previously obtained educational degree (educational and qualification level), based on which admission is carried out;

3) an appendix (notarized copy) to the document on the previously obtained educational degree (educational and qualification level), based on which admission is carried out;

4) an academic certificate (notarized copy) issued by a foreign/Ukrainian educational institution (in case of transfer or renewal of studies, starting from the second year);

5) a document (notarized copy) with information on the content of the curriculum for the previous educational degree, credits received, duration of study and results in academic disciplines when entering to obtain a bachelor's and master's degree;

6) a standardized electronic questionnaire;

7) a certificate of completion of the pre-university training program (preparatory faculty, unit) is provided for admission to studies in the Ukrainian language;

8) 10 photos measuring 30x40 mm.

The documents specified in paragraphs 1-5 must be translated into Ukrainian with a notarized translation. The documents specified in paragraphs 2-5 must be certified in accordance with the legislation of the country of their issuance and legalized by the relevant institution of Ukraine abroad.
